Consumer Price Index

- The Quarterly CPI change in the September quarter of 2021 recorded an increase of 0.06 percent. This is compared the previous quarter of 2020 which recorded a decline of 0.39 percent
- In the September quarter of 2021, the largest contributors to the increase in Somalia CPI were in Food & Non-Alcoholic Beverages, and Restaurant &Hotels. (See Table 1)
- Restaurant &Hotels registered an increase of 1.22 percent during the September quarter of 2021. The increase in Restaurant &Hotels was mainly the result of higher prices of Catering services (1.95%).



- Food & Non-Alcoholic Beverages registered an increase of 0.17 per cent during the September quarter of 2021. The increase in the September quarter was mainly as a result of higher prices of food (0.21%).
- Transport registered an increase of 0.17 per cent during the September quarter of 2021. The increase was largely due to the increase in the Operation of personal transport equipment (0.68%)
- The table below illustrates the percentage changes for the June quarters of 2021 and 2020.

Figure 1: September quarter CPI Change for 2020 & 2021




Figure 2: September Quarter CPI Change for 2021

Trade Statistics

Foreign trade statistics play an important role in many economies and Somalia is no exception. It is an account of all transactions of merchandise between domestic residents and the rest of the world. The overall value of exports and imports for Q3-2021 were estimated at \$218,605,164.11 and \$1,349,886,233.35 respectively. Total trade (export plus imports) amounted to \$1,568,491,397 from \$1,160,475,964 recorded in the previous quarter. Somalia registered a trade deficit of \$1,131,281,069 during the September quarter of 2021. The observed decline in domestic exports was largely driven by low foreign demand for goods and services.

Exports

Export of animals represents the largest share of Somalia's export earnings. The three types of livestock that Somalia exports are Sheep/Goat, camel, and cattle. The exports from Somalia other than livestock are Animal skin products, Crops & Vegetable Oil, forest products, and others. Livestock (\$189,139,148.94), Animal skins products (\$9,289,812.50), as well as Crops and vegetable oil (\$13,572,716.67) were the leading commodities exported by the local economy in Q3-2021. Together, these commodities made up 96.98 percent of the total exports.

As the comparative figures between September quarter 2021 and 2020 below show, September quarter 2021 has the highest percentage increase in exports (28.29%) compared to the same quarter in the previous year. Other exports in the September quarter of 2021 were 536.08% higher than exports of the same quarter in 2020. In addition, Crops & Vegetable Oil exports were 59.38% higher than the previous quarter and livestock accounted an increase of 31.17% during the September quarter of 2021 compared to the September quarter of 2020.

Figure 3: Comparison of Exportation (July-September) 2020 & 2021




Figure 4: Exportation (July-September) 2021





Figure 5: Percentage change for exports (July-September) 2020 $\&\,2021$



Imports

Somalia imports a wide range of products consisting mainly of food items, Oil products, construction, clothes & footwear, medical products, Beverages & Tobacco and cars and spare parts, etc. Food (\$371,328,526.55), Construction (\$209,036,172.65), as well Other (\$180,528,538.66) were the leading commodities imported by the local economy in Q3-2021. Together, these commodities made up 56.37 percent of the total imports. The country relies on food imports despite enough arable land in the country.


September quarter 2021 recorded a high percentage increase in imports (36.34%) compared to the same quarter in the previous year. Other import in the September quarter of 2021 were 374.17% higher than imports of the same quarter in 2020. Moreover, Cosmetics imports were 136.56% higher than the previous quarter.

Figure 6: Summary of Imports for (July-September) 2021





Figure 9: Exchange Rate (July-Sep) 2020



Remittance

Remittances are an important source of income, especially in Somalia. The unemployment rate in Somalia was 21.4% with respective rates of 18.4% and 27.4% for males and females This, coupled with a fragile economy, leaves a large part of the population without a stable and secure income, these circumstances make remittances an important livelihood strategy and livelihood for Somali households. Somalia has a heavy dependence on the US dollar in financial asset transactions, with 100 percent of bank deposits in USD.

In Somalia, remittances declined in the first few months of the pandemic, and despite COVID 19, remittance flows were stable in the September 2021 quarter. The largest variance can be seen in Q3 2021, which improved on the same period for Q3 2020 by 15.21 percent. The largest increase observed during September quarter 2021 was NGOs sector and it has been attributed to the COVID19 Crisis.

Individuals remittance recorded an increase of 19.27 percent during the September quarter of 2021 compared same quarter in the previous year. Business remittances in the September quarter of 2021 were 12.56% lower than Business remittances of the same quarter in 2020. Also, NGOs remittances were 48.50% higher than the previous quarter.

Figure 11: Remittance (July-September) 2021




Figure 12: Remittance (July-September) 2020






Figure 14: Remittance for Businesses (July-September) 2020 & 2021





COVID 19

This Section aim to provide insights to the government, statistical community, donors, development partners, and the general public to ensure that emergency response plans and strategic decisions are based on facts. It also enables resource prioritization and supports technical cooperation in crisis management.

The global pandemic of COVID-19 was first detected in Mogadishu, Somalia on the 16th of March 2020, when the first COVID-19 case was confirmed by the Ministry of Health of the Federal Government of Somalia. The Virus has been spreading both in Mogadishu and in other regions of the country. The Federal Government responded with drastic measures after the first confirmed COVID-19 case closing borders, schools, limiting travel, and prohibiting most group function.


The total number of confirmed cases examined in Somalia in the September 2021 quarter, according to the Health Ministry, was 4,432 compared to the September 2020 quarter with a total of 784 confirmed cases.

The overall total number of confirmed cases in both males and females during Q3-2021 was estimated to be 2,063 and 2,382 respectively. The percentage of male confirmed cases were 53.59 percent compared with the percentage of female confirmed cases which was 46.41 percent. The tables below show the total number of confirmed cases by gender & age during the September quarter of 2021 & 2020.

Figure 17: Total number of confirmed cases by age & gender (July-September) 2021


