# CONSUMER PRICE INDEX (CPI) AUGUST 2024



### **Executive Summary**

The All-Groups CPI was 151.04 in the month of August 2024, compared with 152.92 in the month of July 2024.

The monthly change, August 2024 compared to July 2024, was a decrease of -1.23 percent. The most significant monthly price increases were on **Clothing & Footwear** (3.40%). The increase in **Clothing & Footwear** was mainly the result of increase in prices of **Clothing** (+4.15%).


Over the twelve months to the month of August 2024 (inflation rate), the All-Groups CPI increased to 5.93 percent, compared with 5.54 percent over the twelve months to the month of July 2024.

General Inflation rate: All Groups CPI, August 2024

The rate of inflation for August 2024 is the percentage change in the Consumer Price Index (CPI) over the twelve-month period, from August 2023 to August 2024.

The **All-Groups CPI** increased to 5.93 percent over the twelve months to August2024 compared to 5.54 percent over the twelve months to July 2023.

The All-Groups CPI monthly change for August 2024 was a decrease of -1.23 percent.


#### General Inflation rate: Selected Groups, August2024.

The rate of inflation for **Food and Non-Alcoholic Beverages** and **Housing, Water, Electricity, Gas** are the most significant items in the consumer basket in terms of expenditure and have the largest weighted influence on the **All-Groups CPI**.

**Food and Non-Alcoholic Beverages** experienced a monthly decrease of 2.82 percent during the month of August 2024 compared with an increase of -0.75 percent in July 2024. This was due to increase in the prices of some foodstuffs. As a result, the year-on-year inflation increased to -1.01 percent in August 2024. This is compared to the year-on-year inflation of -1.19 percent experienced in July 2024.

**Housing, Water, Electricity, and Gas** experienced a monthly decrease of -0.15 percent during the month of August 2024. The year-on-year inflation increased to 6.89 percent in August2024. This is compared to the year-on-year inflation of 6.84 percent increase experienced in July 2024.



#### **Major contributions (positive):**


- **Communication** recorded an annual increase of 42.70 percent in August 2024. Most of the upward contribution came from prices on telephone and telefax equipment (+59.44%).
- **Hotels & Restaurants** recorded an annual increase of 32.24 percent in August 2024. Most of the upward contribution came from prices on hotels (+50.11%).
- **Recreation & Culture** recorded an annual increase of 31.40 percent in August 2024. Most of the upward contribution came from prices on Audio-Visual, Photographic and Information (+39.12%).
- **Miscellaneous** recorded an annual increase of 23.20 percent in August 2024. Most of the upward contribution came from prices on personal care (+24.34%).
- Clothing & Footwear recorded an annual increase of 22.62 percent in August2024. Most of the upward contribution came from prices on clothing (+24.76%) due to the increase in prices of Garment for children (+95.29%).
- **Transport** recorded an annual increase of 17.66 percent in August 2024. Most of the upward contribution came from prices on purchase of Vehicles (+23.59%).
- **Furnishing, Households and Maintenance** recorded an annual increase of 16.01 percent in Augus t2024. Most of the upward contribution came from prices on Household Textiles (+20.56%).
- **Housing rent and electricity** recorded an annual increase of 6.89 percent in August2024. Most of the upward contribution came from prices on materials for the maintenance and repair of the dwelling (+24.91%).
- **Health** recorded an annual increase of 6.62 percent in August2024. Most of the upward contribution came from prices on Health Services (+13.65%).

#### **Major contributions (negative):**

- **Tobacco & Narcotics** recorded an annual decrease of -12.21 percent in August2024. Most of the downward contribution came from prices on Tobacco, especially cigarettes (- 26.15%).
- **Education** recorded an annual decrease of -6.15 percent in August2024. Most of the downward contribution came from prices on post-Secondary Non Tertiary Education (- 12.60%).

#### B. Major contributions of the different groups to the monthly percentage change in the CPI

#### **Major contributions (positive):**

• Clothing & Footwear recorded a monthly increase of 3.40 percent in August 2024. Most of the upward contribution came from prices on clothing (4.15%) due to the increase in prices of Garment for children (8.05%).

#### **Major contributions (Negative):**

- **Education** recorded a monthly decrease of -5.11 percent in August2024. Most of the downward contribution came from prices on post-Secondary Non-Tertiary Education (- 38.42%).
- Food & Non-Alcoholic Beverages recorded a monthly decrease of -2.82 percent in August 2024. Most of the downward contribution came from prices on Food (2.85).

The Consumer Price Index is generated by conducting a survey of purchaser prices for a representative basket of household consumption (goods and services), during the first and third weeks of the collection month. The prices are obtained from selected retail outlets in four data collection zones spread across Mogadishu.


